NOTE

Under Internal Revenue Regulations, tax-exempt charitable organizations generally must provide requesters with COPIES of:

- Its approved exemption applications, all required attachments and any related correspondence with the IRS, and
- Its three most recent annual information returns (Form 990), including all schedules and attachments (but not the names and addresses of contributors).

In-person requests: *A member of the public may request to inspect the documents at any principal office of the organization. The entity must provide the information requested that same day. However, if the request places an “unreasonable burden” on the organization, the staff must provide copies of the requested information no later than the next business day after the unusual circumstances cease to exist (limited to a maximum of five business days after the request).*

Written requests: *Written requests made by fax, mail, email, or overnight service, which include the requester’s address, must be honored within 30 days of receipt.*

Website alternative: *Instead of providing copies, an organization may make the documents available on either its own or another organization's website. If it uses this option, it has to: (1) provide an exact replica of the document as was filed with the IRS; (2) advise requesters how to access the forms on the web; (3) the site should charge no access fee and require no special software or hardware to download. Organizations that post this information on the Internet still must honor in-person requests to view the applicable documents.*

Permissible charges: *Tax-exempt organizations may charge a reasonable copying fee, up to \$1 for the first page and 15 cents for each additional page, plus actual postage costs.*

Penalties: *An organization that fails to comply with the new disclosure requirements may be subject to the following penalties:*

- Annual Information Return – Form 990 - \$20 per day for as long as the failure continues, up to a maximum of \$10,000 for each failure to provide an annual return.
- Exemption Application - \$20 per day with no maximum.
- An organization that willfully fails to comply with these public inspection rules can be subject to an additional \$5,000 penalty.

Private foundation exempt: *The new disclosure rules don't yet apply to private foundations. They must still make a copy of their annual return available for public inspection at their principal office for a period of 180 days after publishing a notice of availability.*

1 Briefly describe the organization's mission: Amigos for Christ exists to serve God. We do this by two approaches. First, we facilitate sustainable, locally-empowered improvements in water, health, education, and economic infrastructure in rural Nicaraguan communities by developing leaders, integrating ourselves

4a (Code:) (Expenses \$ 6,046,143. including grants of \$ 6,046,143.) (Revenue \$ 8,318.) Health & Economic Development: We believe the key to increasing individual wealth and healthiness lies in knowledge and empowerment. In 2015, we conducted 814 health examinations to educate community members about the risks of parasites. We helped 9 woman build new externally vented kitchens to reduce the toxic level of smoke their families were inhaling whenever they cooked. We also built a new pig farm and 3 chicken coops to internally source our animal microcredit program.

4b (Code:) (Expenses \$ 413,889. including grants of \$ 413,889.) (Revenue \$) Education & Nutrition: We aim for 100% graduation from elementary school for the children in our partner communities. To accomplish this, in 2015 we built a new school for a community whose previous school was entirely constructed of sticks and plastic sheets. We fed 534 students lunch throughout the year to incentivize parents to bring their kids to school. We provided afterschool arts and sports programs to motivate 762 students to attend class. And we provided 85 secondary/college students with scholarships that allow them to continue their studies.

4c (Code:) (Expenses \$ 565,752. including grants of \$ 564,766.) (Revenue \$) Water & Sanitation: We work in 17 communities with the goal of eliminating kidney and parasitic diseases that stem from dehydration and poor sanitary standards. First, we help communities develop leadership to mobilize the communities and visualize the end goal. We then assist in the digging of wells and laying of pipe, so that every home in each community can have access to fresh water. The final steps include the removal of latrines--which have proven to be ineffective at reducing parasites-- and the installation of bathrooms with flushing toilets and showers. In 2015 we dug 3 new community wells, laid over 11,000 meters of pipe, removed 37 latrines, and installed 68 modern bathrooms.
