

Amigos for Christ Donor Privacy Policy

This Privacy Policy applies to collection of information, including information collected on our website. By submitting your information to us or any of our staff, you consent to the terms and conditions of the policy and to our processing personal information for the purposes stated below.

Amigos for Christ is firmly committed to the privacy of our donors and to the integrity of our records. Outlined below are the policies we use to protect your privacy and safeguard any information you entrust to us. Personal Information

“Personal Information” is information that identifies you personally, such as your name, address, telephone number, and email address. We collect and store the personally identifiable information that you have provided us.

Ways in which we may collect your information:

- When you request information via one of the email addresses identified on our website or otherwise contact us in person, by phone or email, with a question. We may then collect your name, address and email in order to respond to that inquiry.
- We may collect your name, email address and other contact information if you register for an event or mission trip.
- We may collect your name, email address, telephone number and payment information when you make a contribution, either on our website, over the phone or by mailing in a check.

The above list provides a sample of personal information that may be collected by Amigos for Christ. From time to time, we may collect personal information from you in ways not described above.

Use and Disclosure of Personal Information

- We will not sell, trade, or share your personal information, collected on the website or through any other business activities with anyone else, except those Amigos for Christ Board members or other key engaged volunteers who are working on behalf of Amigos for Christ or as otherwise described in this Privacy Policy.
- We will not send you mailings on behalf of other organizations.
- We may share your personal information if you give us specific permission to do so.

- We will collect payment information, billing address and other information necessary to process a donation or event registration through our [online giving portal](#) described below.
- We will use and share your information to comply with applicable law or in the good faith belief that such action is necessary to conform to the requirements of applicable law or comply with legal process served on us, protect and defend our rights or act in urgent circumstances to protect the personal safety of others.
- We will use the personal information to protect against potential fraud.
- We may verify with third parties the information collected in the course of processing a gift, event registration or other donation. If you use a credit or debit card on the website, we may use card authorization and fraud screening services to verify that your card information and address matches the information that you supplied to us and that the card being used has not been reported lost or stolen.

Specific Ways we Protect Donor Information:

Online giving: Our website is linked to Donor Perfect, a division of SofterWare to provide donors with a safe, secure and private facility for making online credit-card gifts. For more information in Donor Perfect’s Privacy Policy please [click here](#).

Email list and Mailings: We will send short email updates to you for various reasons, such as a thank you for your contribution, to send you a receipt for your donation, and other Amigos for Christ news. If you ever decide you do not want these updates, you can change your preference, unsubscribe, or email a request to be removed to info@amigosforchrist.org.

Amigos for Christ does not send mailings to people who just visit our website. We send very limited communications by mail to our Donors. If you would prefer not to receive any mail, you may request this by emailing info@amigosforchrist.org, and we will mark your record accordingly.

Virus protection: Amigos for Christ uses commercially reasonable efforts to protect its systems with firewalls and leading anti-virus protection software. We update our email system anti-virus protection software regularly.

Cookies: Visitors should be aware that certain information and data may be automatically collected by the Amigos for Christ website or third-party service providers through the use of “cookies.” “Cookies” are small text files a website can use to recognize repeat visitors, facilitate the visitor’s ongoing access to and use of the site, and allow a site to track usage behavior and compile aggregate data that will allow content improvements. Cookies are not programs that come onto a visitor’s system and damage files. Generally, cookies work by

assigning a unique number to the visitor that has no meaning outside the assigning site. If a visitor does not want information collected through the use of cookies, there is a simple procedure in most browsers that allows the visitor to deny or accept the cookie feature. Amigos for Christ uses “cookie” technology only to obtain information that is not personally identifiable to us from its online visitors in order to improve visitors’ online experience and facilitate their visit within our site.

Specifically, we use Google Analytics, a web analysis service provided by Google, in order to better understand your use of the Amigos for Christ website and how we can improve it. Google Analytics collects information such as how often users visit a website, what pages you visit when you do so, and what other websites you used prior to coming to such website. Google Analytics collects only the IP address assigned to you on the date you visit a website, rather than your name or other directly identifying information. We do not combine the information collected through the use of Google Analytics with personal information. Although Google Analytics plants a persistent cookie on your web browser to identify you as a unique user the next time you visit a website, the cookie cannot be used by anyone but Google. Google Analytics uses its cookie(s) and the other information Google Analytics collects to track your online activities over time and across different websites when you use the Amigos for Christ website, and other websites. Google’s ability to use and share information collected by Google Analytics about your visits to the Amigos for Christ website is governed by the [Google Analytics Terms of Service](#) and the [Google Privacy Policy](#). Google utilizes the data collected to track and examine the use of the Amigos for Christ website, to prepare reports on its activities, and share them with other Google services. Except as described in this Privacy Policy or at the time we request the information, we do not otherwise disclose your personal information to any third parties. Further, **Amigos for Christ** will not sell or trade your personally identifiable information to any third parties.
